RE: TUITION & FEES, 2024-25 ACADEMIC YEAR

As you prepare for the 2024-25 academic year, we hope this information will serve as a guide as you plan to pay your tuition and fees.

Tuition and fees are due by the first day of classes each quarter. Tuition for the 2024-25 academic year is \$58,144.* Tuition due dates:

There is a \$50 fee assessed for late payment of tuition and fees if not paid within 10 days of the due date. All outstanding accounts are subject to interest at the rate of .5% per month on the unpaid balance from the prior month.

Tuition Prepayment Policy

Any student wishing to prepay his/her tuition for one or two years beyond the current year's tuition may do so at the current year's tuition rate provided that full payment for current year and all other years to be prepaid is received by Student Accounts Services no later than 30 days following the first day of the current year Fall Quarter. Future annual tuition increases will not be charged to those students who have elected to prepay any future full year's tuition.

Any student who is dismissed or officially withdraws from the program, as per the requirements stated in the catalog, will have his/her prepaid tuition returned in full except for the current year's tuition which will be refunded as per the stated policy in the College catalog.

In addition, a student may make partial payments to his/her tuition account as long as the quarterly tuition amount is collected by the due date noted on the attached letter.
